Subject: EXPRESSION OF INTEREST FOR PERFORMANCE OF AEROBATIC DISPLAYS AT AERO INDIA 2019.

Last date of submission: 21.12.2018 by 18:00 hrs

1. Background:

The Department of Defence Production (DDP) deals with matters pertaining to defence production, indigenization of imported stores, equipment and spares, planning and control of departmental production units of the Ordnance Factory Board and Defence Public Sector Undertakings (DPSUs). It also engages with the private sector licensed for Defence Production and export of various defence related systems, equipment, components etc. DDP is also responsible for the organization of Aero India. Further details of the organization can be obtained from our website http://ddpmod.gov.in.

Aero India is a biennial air show and defence exhibition organized by the Department of Defence Production, Government of India. The 12th edition of Aero India is scheduled to be held from 20th to 24th February 2019 in Bengaluru. Aero India is the largest air show in Asia and attracts a large number of exhibitors from the world's leading industries in the field of military and Civil Aviation, Aerospace, Airport Infrastructure and Defence Engineering. The show includes both air displays and static exhibitions of a large array of civil and military platforms from the Aerospace sector.

DDP proposes to secure the appointment of aerobatic teams that will arrange the supply of (1) AIRCRAFTS; and (2) TEAMS, to perform AEROBATIC DISPLAYS at Aero India 2019.

2. Cancellation or Non-Performance of Agreement by Aerobatic Team:

If during the Aero India 2019 event the Aerobatic Team fails to perform displays occasioned by any event caused by the negligence, fault or default, the Aerobatic Team shall be charged a penalty of 2.5% from the total CONSIDERATION per unserviceable AIRCRAFT per DISPLAY.

3. <u>Evaluation of the Aerobatic Teams will be done on the basis of the followings:</u>

*detailed response (along with relevant documentation) to below mentioned evaluation criteria should be shared as part of the EOI answer

- I. The applicant shall be a team consisting of between 2 and 10 aircraft
- II. The applicant should have significant experience performing at Air Shows
- III. The individual pilots of the applicant team should have all relevant licenses and clearances to perform as part of an aerobatics team
- IV. The applicant team should have all relevant licenses and clearances to perform as part of an aerobatics team
- V. All civil aircraft pilots must show evidence of performing or practicing their performance(s) within the previous 15 days
- VI. All civil aircraft pilots that perform formation aerobatics must ensure the following requirements are met:
 - a. The members of the aerobatic team must have performed together in 8 aerobatic performances over the preceding 12 months; or
 - b. When the team members have flown fewer than 8 aerobatic performances in the past 12 months, the team must be able to document 30 aerobatic practice sessions or combination of 30 practice sessions and air show performances as a team over the preceding 12 months in the performing aircraft type.
- VII. The applicant should provide details around the specific displays / performances that will be undertaken during the show
 - a. Complying documents: Description of display / performance. If applicable, recording / video of display at a prior event.
- VIII. The Aerobatics Team Aircraft manoeuvres may not direct energy toward primary spectator areas and must comply with show lines (man-made or natural)
 - a. Non-aerobatic manoeuvres where the aircraft is pointed at the primary spectator area are permitted as long as the aircraft is beyond the appropriate show line for category without energy towards the crowd considerations

- IX. a. The Aerobatic display team should be covered by adequate third party liability insurance per aircraft, copies of all such insurance policies may be shared with the organizers of Aero India 2019.
 - b. The responsibility of insurance cover in all forms (Medical, Emergency expenses, flying as pilot, as a passenger, crew member etc.) for each member of the Aerobatic display team lies with the concerned company/team.
 - c. Organiser shall not in any manner take any responsibility for any loss or damage suffered to the Aircraft and the team caused by any negligence mistake, wilful misconduct, fault by the aerobatic team.
